2. Absolutely no manufactured crafts items will be accepted. If advised by Artists in Partnership, Inc. that you are selling items other than those approved, such items **MUST** be removed. Failure to do so immediately cancels this agreement and you will be asked to leave. **NO REFUNDS.**
3. Exhibitors must provide all display facilities, chairs, plastic covers, (in case of sudden rain), and are responsible for transporting, unloading, setting-up, breaking-down, and removal of all their goods and display materials.
4. **NO REFUNDS** due to weather conditions.
5. Set-up time: 11-1pm. Break-down time: 7 pm.
